- AXA BANK EUROPE SA/NV is authorized under the laws of the Kingdom of Belgium to conduct banking activities as referred to in Article 4 (see annexe), of the above-mentioned Law, and effectively conducts such activities in Belgium.
- AXA BANK EUROPE SA/NV is authorized to conduct following banking activities in Hungary, in accordance with the notification dated 22 August 2008 of the establishment of a branch in Hungary :
 - o Acceptance of deposits and other repayable funds from the public
 - o Lending
 - o Money transmission services
 - Issuing and administering means of payments (e.g. credit cards, travellers' cheques and bankers' drafts)
 - o Guarantees and commitments,

The Law of 25 April 2014 on the legal status and the supervision of credit institutions replaces the Law of 22 March 1993 on the legal status and supervision of credit institutions, that was previously applicable.

<u>List of activities as referred to in Article 4 of the Belgian Law of 25 April 2014</u> on the legal status and the supervision of credit institutions:

- 1. Taking deposits and other funds
- 2. Lending including, inter alia: consumer credit, credit agreements relating to immovable property, factoring, with or without recourse, financing of commercial transactions (including forfeiting)
- 3. Financial leasing
- 4. Payment services as defined in the Law of 25 April 2014
- 5. Issuing and administering other means of payment (e.g. travellers' cheques and bankers' drafts) insofar as such activity is not covered by point 4
- 6. Guarantees and commitments
- 7. Trading for own account or for account of customers in any of the following
 - a. Money market instruments (cheques, bills, certificates of deposit, etc.)
 - b. Foreign exchange
 - c. Financial futures and options
 - d. Exchange and interest-rate instruments
 - e. Transferable securities
- 8. Participation in securities issues and the provision of services relating to such issues
- Advice to undertakings on capital structure, industrial strategy and related questions and advice as well as services relating to mergers and the purchase of undertakings
- 10. Money broking
- 11. Portfolio management and advice
- 12. Safekeeping and administration of securities
- 13. Credit reference services
- 14. Safe custody services
- 15. Issuing electronic money
