1. DETAILS OF THE WORK

2. SPECIFICATION OF TECHNICAL AIDS AND INFORMATION NEEDED BY THE CONTRACTOR

- estimated number of documents reclassified by an EPO examiner in 1 hour: 8,5 doc/hour

3. VALIDATION, ACCEPTANCE, RESPONSE AND REPAIR TIME

Specific criteria:

- Lack of correctness: a document will be rejected if there is more than one unjustified/superfluous essential symbol assigned to this document. Other specific criteria can be defined if needed.
- Lack of completeness: a document will be rejected if there is at least one essential symbol missing for this document. Other specific criteria can be defined if needed.
- Lack of timeliness: a complete batch under "normal inspection" will be rejected if there is more than two days of delay and if this has not been notified to the EPO in time. A complete batch under "tightened inspection" will be rejected if it is not delivered within the period as defined in the agreement (zero tolerance).

4. PRICE

Fixed price: **EUR 15 / document**. This fixed price per document has been calculated in accordance with article 6.2 of the Agreement.

No early payment discount if the EPO pays within **10 days** from receipt.

5. TRAVEL AND ACCOMMODATION

The Contractor is not entitled to reimbursement of expenses for travel and accommodation.
